Convention on Contracts of the International Sale of Goods (CISG)

- As of February 2009, 73 States have adopted the CISG as uniform sales law.
- The CISG is implemented federally and in all provinces and territories, including Ontario as the *International Sale of Goods Act*.
- The CISG applies to most international sale of goods contracts with parties in western countries.
- The CISG applies to litigation involving international parties with disputes involving goods.

If you are a commercial lawyer or litigator this is a **'must attend'**.
