She has never lost her passion for families in crisis and for the rights of children. In addition, Mary Jo was an adjunct professor in the Faculty of Law, University of Windsor, teaching Civil Procedure and Civil Trial Advocacy from 1999 until her appointment to the Court. She has been a member of the Civil Rules Committee, the Unified Family Court Expansion Project, the Provincial Case Management Steering Committee and a member of the Civil Justice Review Committee – Family Group. Mary Jo continues her involvement with the Faculty of Law as a frequent guest lecturer and as a student mentor. On her retirement from the court, her judicial colleagues and family endowed an annual financial award in her name for a student with an interest in pursuing a career in family law. Mary Jo has a unique background of experience in all aspects of the justice system in Ontario with a particular concern for families and children. She brings this knowledge and experience to her work as a mediator and arbitrator. On June 19, 2017 the Law Society of Upper Canada conferred on Mary Jo the Degree of Doctor of Laws , honoris causa,(LLD) in recognition of her contributions throughout her career to access to Justice.
