#1 Substantive Track PM: Policing and Marginalized Communities

Marginalized communities are grossly over-represented in Canada's criminal justice system. Policing in Indigenous communities presents unique challenges that are distinct from other communities. Are political, socio-economic, cultural and historical contexts being considered when policing Indigenous people? The Ontario Police Services Act and other provincial Acts require effective and inclusive policing to ensure the safety of their communities and to safeguard the Charter. In January 2017, new Ontario rules restricting arbitrary police carding took effect. Now almost three years later, have arbitrary stops against people of colour been reduced?
