Brad's practice includes complex commercial cases, arbitrations and precedent-setting public interest litigation. He has appeared as lead counsel across the country, including regularly at the Supreme Court of Canada. Brad was the Practice Group Leader for Blakes Litigation in Toronto for eleven years (2010-2021).

Brad is a past president of The Advocates' Society and a Fellow of the Chartered Institute of Arbitrators (FCIArb). He taught trial advocacy at Osgoode Hall Law School for six years and is currently a contributing editor to *Canadian Legal Practice* (Butterworths/LexisNexis). Among other things, Brad was co-chair of a 2015 joint task force of The Indigenous Bar Association, The Advocates' Society and the Law Society of Ontario to develop *Guidelines for Lawyers Working with Indigenous Peoples*, a national project in response to the Report of the Truth and Reconciliation Commission.

Brad clerked to the Saskatchewan Court of Appeal and serves on the Law Dean's Advisory Council for the University of Saskatchewan. Brad is a director of the CAMH Foundation Board supporting mental health across Canada. He is closely involved with several other community agencies, including AIDS Committee of Toronto, the Canadian Civil Liberties Association and the Metropolitan Community Church of Toronto.

Diversity and giving back are long-standing passions for Brad. He was the first lawyer to start "out" at Blakes and one of the first on Bay Street at the time. He has been involved with many of Canada's leading LGBTQ+ organizations over the years, including as co-chair of OBA SOGIC in the late 1990s. Among other things, Brad and his husband Brian Rolfes have established an annual scholarship at the University of Saskatchewan College of Law recognizing upper year achievement by LGBTQ+ students and allies.
